In his interactive multimedia presentation, Dr. Hanson will consider the complex and contested topic of lynx and wolf reintroductions to the UK. Could and should they happen? Jonny will take us on a global journey to answer these questions, drawing especially on his work on snow leopard conservation in Nepal, and his upbringing in Malawi.

Jonny Hanson is an environmental social scientist at Queen's University Belfast and an award-winning social entrepreneur who set up and managed Northern Ireland's first community-owned farm. Raised between Malawi, Africa, and Monaghan, Ireland, he has a PhD in snow leopard conservation from the University of Cambridge and is an Affiliate of the Snow Leopard Conservancy. 

Notes from the field

It has been an energising and humbling start to my tenure as Research Co-ordinator for the Nyika-Vwaza Co-Management Trust (NVCMT). Over the past few weeks, I've been immersed in fieldwork across Nyika and Vwaza reconnecting with communities, reviewing ecological monitoring, and shaping our research priorities around the realities of the landscape.

One evening in Vwaza, I watched a lone hippo on the banks of Lake Kazuni after a scorching day, just a week since launching the Nyika-Vwaza Gravity-fed piped water scheme on 7 August. The scheme, tapping water from Nyika National Park, now delivers safe water to communities around both parks, reducing the need to enter wildlife zones and risk encounters with hippos, crocodiles, elephants, and buffalo. Seeing women and children celebrate clean water access from this initiative was a powerful reminder of how conservation and community wellbeing go hand in hand, and why research must help replicate and enhance such synergies under the Trust.

My immediate priority is strengthening the bridge between research and decision-making. This primarily means developing a strategic research and monitoring plan that supports adaptive management across the Trust's operational areas (i.e., law enforcement, human-wildlife coexistence management, ecosystem health, and sustainable community livelihoods). A workshop in early September (2025) will help refine our data systems so that biodiversity surveys, resource protection and patrol threat assessments, as well as community feedback directly inform the Trust's management actions.

As Prof. Nambota of Peace Parks Foundation (also Board member of the Trust) often says, "conservation without communities is a mere conversation". That ethos is central to the Trusts' approach. Communities are not just subjects of study but active contributors to knowledge generation in the management of the two parks. Driven by this ethos, we'll be reactivating partnerships with longstanding players in the landscape such as Lilongwe Wildlife Trust, academic institutions, and independent researchers to support priority studies and build scientific capacity of the Trust. The work ahead includes a focus on strengthening the Trust's MEL system, and commencing ecological studies and social research as below;

- Systems Strengthening: Standardized methodologies for data management (collection, storage, and reporting), data integration, and participatory monitoring.
- Ecological Focus: Orchid sustainability, fire ecology, invasive species, land-use change.
- Social Research: Community attitudes, tourism potential, scalable livelihood interventions.

As we move forward, I'm committed to fostering collaborations that bridge science, policy, and local knowledge. Expect more updates in future editions as we deepen our commitment to inclusive and evidence-driven conservation. Next time, I hope to share insights from our capacity review and how local custodians are gearing up to support the Trust's research strategy.

Wildlife and Environmental Education Sourcebook for Primary Schools

Lilongwe Wildlife Trust (LWT) partnership with The Ministry of Basic and Secondary Education (MoBSE), namely Malawi Institute of Education (MIE) and Directorate of Quality Assurance Services (DQAS) is getting stronger each day. Now that the sourcebook has been published, launched and was rolled out in 2024, LWT continued to mobilise resources to scale up the implementation of the sourcebook towards reaching the target of over 5,000 primary schools. The resources will also support continued engagement with MIE and DQAS to ensure that the curriculum integrates wildlife and environmental education. To date a total of 1,970 books have been printed, and a further 1,030 will be printed in August 2025.

In April 2025, LWT engaged MoBSE - especially coordinators and curriculum development personnel within MIE and DQAS - to explore ways in which LWT, with its sourcebook, would participate in the curriculum development process and, at the same time, lobby integration of wildlife and environmental education. MoBSE was very positive that the content of the sourcebook will be used in the curriculum review/development because it addresses the agenda's 63 enablers which are also informing the curriculum process. MoBSE recommended that the sourcebook undergo a levelling exercise. In August 2025, LWT initiated a sourcebook

levelling meeting with a team of curriculum specialists and quality assurance officers in MoBSE as part of the process of ensuring that the sourcebook adequately and appropriately supports teachers and learners. The content of all the eight units of the sourcebook was divided among six grades according to level of difficulty. Six grades were used in the levelling exercise considering that the 2025 curriculum framework proposes a 6-year primary school compared to the current 8 years of primary school. The curriculum framework also proposed a pre-primary school and a competency/skill-based curriculum rather than the current outcome/result-based curriculum.

LWT and its partners, MIE and DQAS, are continuing to plan more printing of books, translation of the sourcebook into Tumbuka and Chichewa, developing radio and video programmes of the sources and teachers training.

Expanding Liliongwe Wildlife Trust's Environmental Education

The Lilongwe Wildlife Environmental Education Programme aims at expanding LWT's environmental education and now it is in the second year. The project is making strides in increasing the reach of environmental education activities undertaken by the LWT EEC, and increasing the impact on Malawian school children, students and (aspiring) teachers of the environmental educational activities. The project is famous amongst learners and environmental educators, especially with regular learning visits to protected areas, teachers training, consultations and environmental educators learning exchange.

An education visit to Liwonde National Park with 28 learners from four schools was conducted providing students with practical knowledge of wildlife management and conservation through guided game drives led by experienced Africa Parks guides. The visit also included learner guidance on establishing and managing wildlife clubs, training on meeting facilitation, leadership selection, and activity planning including debates, art competitions, and environmental clean-up initiatives.

Teacher training and consultative meetings were conducted and the teachers' workshop aimed at equipping educators with knowledge of environmental education. The training showcased the potential impacts of environmental education programs in fostering conservation awareness. This integration creates a foundation for expanding environmental education across diverse educational institutions. The comprehensive three-day stakeholder workshop served as a strategic platform to showcase EEC's conservation work, outlined its educational missions, and fostered prolific partnerships with key stakeholders. The event provided an opportunity for the LWT to demonstrate EEC's collaborative work with schools, colleges, universities, communities and partners, while presenting future environmental education initiatives. This multi-institutional engagement established a foundation for structured and impactful collaboration in implementing EEC's environmental education initiatives across various educational and community sectors.

We are delighted to see the progress that LWT continues to make. The Nyika-Vwaza UK Trust has been involved with, and has financially supported, the environmental education programme through the curriculum and source book projects and now the Education Centre, for many years. It is gratifying for us and for our donors to see investment bearing fruit.

NVT Research grants

Gracious Lokoma should have recently arrived on the Nyika Plateau to start his research study on 'Avian-flora interactions: investigating the role of fruiting plants in shaping the distribution and diversity of significant ecotourism bird species in Nyika National Park'. His first task is to ensure that all the logistics are in place and that he has transportation, accommodation and of course food. The project's main objective is to reveal crucial ecological insights into the correlation between the presence of prolific touristic bird species and the seasonal production of fruits in Nyika National Park. He will collect data in both the dry and wet seasons and aims to produce his report in early summer 2026. We very much look forward to reading it.

Explanation of the accounts

Income

- Funds from donations are divided into Unrestricted Funds (which trustees are free to use for any purpose in line with the charitable objects), and Restricted Funds (which are designated for specific projects).
- Interest refers to interest on the investment account, which has now been closed and the money transferred to the bank account.

Expenditure

- NVCMT Research Support: This is the first payment towards the three-year Research Support programme for the Nyika Vwaza Co-Management Trust which NVT is funding. The programme is being overseen by the Peace Parks Foundation. NVT has committed a total of £150,000 towards this project
- LWT Environmental Education Centre: NVT has committed to support LWT's Environmental Education Programme for a three-year period (total £45,000, ending March 2027).
- Research Grants covers grants made during 2024/25. This programme will continue, with reduced funds, due to capital being directed to the NVCMT programme.

Expenditure exceeds income for the year, and the difference was funded by drawing on the Happold Africa Fund, and using the remaining balance from the Ian Hay legacy funds. All funds are held in Current and Interest-Bearing Accounts with Lloyds Bank.

The Nyika-Vwaza Co-Management Trust — the story so far

You will have read the inspiring piece at the start of this newsletter written by Andrew Kanzunguze. He not only provided us with interesting information, but tickled our imagination by describing the scenes around him.

We thought it might be helpful to explain the bigger picture to Andrew's role as the Nyika-Vwaza Co-Management Trust's research co-ordinator, both with a reminder of how our involvement came about and with a status update.

In February 2023 the Trust received an unexpected donation of £180,638 from the Happold Africa Fund. This generous donation enabled us to continue funding the LWT conservation education work, but also to seek a further project which would be appropriate for us to fund. After lengthy discussions, NVT UK trustees decided that the funds could be deployed to the greatest effect through the Nyika-Vwaza Co-Management Trust, which resulted from an agreement between the Malawi government and the Peace Parks Foundation. This 20-year agreement will enable effective management of the two parks and surrounding communities and NVT UK is funding Andrew Kanzunguze's research role which will inform that management.

In the Peace Parks Foundation article that follows, PPF have described the broad process by which the Trust will bring about changes that will eventually result in better management of the Nyika and Vwaza, as well as benefit the communities of the surrounding area. Changing behaviours takes time and it is vital to work with the local communities to ensure they are deeply involved in creating that change.

So that we can understand how the changes will be planned and implemented, we have asked Peace Parks Foundation to let us have more detailed information on the anticipated community involvement, with photos and examples so that we can better imagine who is involved and get a flavour of how the project is working 'on the ground'. We will share this in future newsletters.



Nyika-Vwaza Co-Management Trust begins bold transition with change management support

Nyika National Park and Vwaza Marsh Wildlife Reserve, critical landscapes in the Malawi-Zambia Transfrontier Conservation Area, are entering a new era. The signing of a co-management agreement between the Government of Malawi and Peace Parks Foundation in 2023 marked the start of a new chapter. At the heart of this agreement is the newly formed Nyika-Vwaza Co-Management Trust, tasked with overseeing the long-term protection and sustainable development of this landscape.

As the Trust officially takes over management, a smooth, people-focused transition is essential, not only to avoid disruption but to lay the foundation for something far more ambitious — a future-ready conservation model that places community involvement and strong leadership at its core.

To ensure this occurs, Peace Parks is bringing in expert change management support through Inspiro, a seasoned practitioner in guiding organisations through strategic transformation. The aim is to empower the newly created park management unit, led by its Chief Executive Officer

(CEO), M. George Nxumayo and Edward Guzani, the Human Resources Manager, to manage this change effectively and sustainably.

Why change management matters

This transition is about more than just handing over responsibilities. It involves re-imagining how these protected areas operate, with a refreshed business-oriented model, increased staff capacity and deeper community engagement. It also involves changing mindsets.

Without clear planning and support, changes in leadership, policy and systems can easily lead to confusion or disengagement. But with structured change management in place from the outset, the Trust can build momentum, strengthen internal alignment and keep its focus on the long-term goals of biodiversity conservation, sustainable tourism and inclusive community development.

The goal is to ensure that everyone, from staff to partners, feels part of the process and is confident in the road ahead.

A four-phase approach to change

The process will follow a flexible, four-phase model, adapted specifically to the needs and context of the Nyika-Vwaza landscape:

- Laying the groundwork Develop the business case for change and craft a shared vision with key stakeholders.
- 2. **Designing the journey** Co-create interventions and communication plans based on real stakeholder input. Activities will include focus groups, feedback loops and hands-on workshops.
- Putting plans into action Implement change initiatives, from workshops and training, to

- establishing a 'change agent' network shaped by feedback and timelines.
- 4. **Making it stick** Equip the park management unit to measure success, gather lessons learned and build momentum for future changes across other sites.

Throughout the process, the park management unit will take the lead, with support provided by Inspiro, Malawi's Department of National Parks and Wildlife, and Peace Parks Foundation. Regular progress updates will be shared with the Trust's board, and external partners will be brought in where needed to ensure shared understanding and continuity.

Timing is key

The time to act is now. With the CEO and HR Manager taking up their roles, the conditions are right to embed change management into the Trust's DNA from day one. Early support will help shape onboarding, establish leadership confidence and ensure a united team ready to guide Nyika-Vwaza into a new era.

Mount Mulanje added to prestigious UNESCO World Heritage List

Some of you may missed the news that Mount Mulanje Cultural Landscape in southern Malawi has been officially inscribed onto the UNESCO World Heritage List. It celebrates the mountain's rich cultural traditions, profound spiritual significance and its ecological value.

For centuries Mount Mulanje has been a sacred site for the Mang'anja, Yao and Lomwe peoples, with sites across the massif continuing to serve as venues for traditional rites and rituals. It offers some of Africa's most breath-taking natural scenery with its deep ravines, rainforest gorges, montane grasslands and miombo woodlands. It is home to the critically endangered Mulanje cedar, Malawi's national tree.


